
## INCIDENTS BY GENDER —



# SUMMER 2017 RESCUE REVIEW

#### » JUNE

RESCUE Overturned Canoe near Elbow Boat Ramp

DATE 6/3/17 TIME 2:08pm

DURATION 1 hour 58 minutes

ATTENDEES

WHAT HAPPENED? SAR received a page regarding an overturned canoe floating near Elbow Boat Ramp. Dispatch reported that a deputy was already headed to check it out. No people were witnessed in the water. SAR decided to wait to hear what the deputy discovered. At 3:03pm SAR received another page that there was no new information about the incident and deputies had put out the word to boaters in the area to call in if they see anyone who needs help. At 4:06pm SAR received a third page that people did fall out of the canoe, they self-rescued, and were all ok. The incident was stood down.

**RESCUE** Gunsight Pass ATV Crash

DATE 6/7/17 TIME 12:43pm

DURATION 3 hours 32 minutes

ATTENDEES 12

WHAT HAPPENED? SAR received a page regarding an ATV accident on Gunsight Pass. Two adults were involved in the crash, one complaining of shoulder pain, one or both complaining of back pain and one of the patients was not doing well and may have suffered a head injury. Air Idaho was available and would respond. SAR arrived on scene and several others were also on scene assisting. Air Idaho HEMS arrived and members from all agencies worked together to package the more critical patient and carry her to the helicopter. The other patient was loaded into the wheeled litter and transported to the two-track where an ambulance took over care and transported her to SJMC.

**RESCUE** Overturned Canoe near Hoback Junction

DATE 6/7/17
TIME 3:47pm
DURATION 29 minutes

ATTENDEES

WHAT HAPPENED? SAR received a page regarding an overturned canoe and one person in the water in the area of the Boy Scout Camp on S Hwy 89. Hoback Fire Department was already paged out. The SAR team was already on an ATV rescue near Gunsight Pass and dispatch reported that a deputy was in route to the scene. At 5:37pm SAR received a follow up page that all parties were ok per the USFS and the incident was stood down.

RESCUE Overturned Kayak near Granite Falls

DATE 6/12/17 TIME 12:45pm

DURATION 2 hours 45 minutes

ATTENDEES

WHAT HAPPENED? SAR received a page regarding a report of an overturned kayak at the base of Granite Creek Falls below Granite Hot Springs. Dispatch reported that a third-party reported a kayak in the water below the falls and no victims were seen. Since there is no known victim or report of a missing person, SAR could only drive down there and assess. SAR arrived at the falls and did not see a kayak, any gear, or people in need of help. There were no cars there capable of carrying a kayak. SAR decided that there was most likely no one in need of help and would stand down unless another report came in that there was a known victim or missing person. The event was stood down.

RESCUE Injured Mountain Biker on Arrow Trail

DATE 6/18/17 TIME 2:12pm

DURATION 4 hours 48 minutes

ATTENDEES 2

WHAT HAPPENED? SAR received a page regarding a female in her 30's who fell while mountain biking on the Phillips Ridge Trail and could no longer walk due to pain in her hip. The team was paged for a wheeled litter and ATV rescue. One team was sent in from the top via the Phillips Pass trailhead and a second team in from the bottom via the powerline access road off Fish Creek Road. Both teams would go in on ATV's. The team from the bottom would bring in the wheeled litter. The team accessed the patient and began assessment and patient care. SAR members packaged the patient in the full-body vacuum mattress and loaded her into the wheeled litter. SAR members transported the patient to Fish Creek Road and transferred the patient to a waiting ambulance.

RESCUE Overdue Hiker near Granite Creek

DATE 6/18/17 TIME 8:47pm

DURATION 1 hour 28 minutes

ATTENDEES 21

WHAT HAPPENED? SAR received a report of an overdue hiker in the Granite Creek/Shoal Creek/Battle Mountain area. Dispatch reported that the missing person (MP) had been mushroom hunting with a group and decided to return to the trailhead before the rest of the group. When the group returned to the trailhead, MP was nowhere to be found. The reporting party stated that MP had a lot of medical issues. Dispatch said that Sublette County Dispatch had received a 911 hang-up call from MP's phone number and a deputy from Sublette County was en route to the area. SAR believed there was enough evidence that this might be a life threat and the team was paged. At 9:47pm dispatch received word that the Sublette County deputy had located the MP about 300 yards from the patrol vehicle. The deputy said he may have trouble getting back to the vehicle with the subject and requested that SAR continue to respond. TCSAR began getting out ATV's to drive to Granite Creek. At 10:13pm dispatch reported that the deputy and subject had made it safely back to the patrol vehicle and SAR could stand down.

**RESCUE** Injured Horseback Rider in Pacific Creek

DATE 6/20/17 TIME 1:11pm

DURATION 3 hours 49 minutes

ATTENDEES 8

WHAT HAPPENED? SAR received a page for an injured horseback rider at Pacific Creek. Report was that a female had fallen off a horse and had been dragged and injured. The rider and guide were across Pacific Creek and to get to her would require crossing Pacific Creek. Team was paged and responded with ATVs. Initial plan was to drive to location across from rider and guide and try to get eyes on as they reported being close to river, then decided if 4 wheelers would work or if swiftwater/ wheeled litter was the option. While en route SAR received word that the patient's condition was declining. The EIRMC Air Methods helicopter was requested. SAR teams went to the outfitter camp involved, just east of the patient location to meet with GTNP staff. The ship landed about 5 minutes before SAR arrived.

RESCUE Injured Hiker on Snow King

DATE 6/24/17 TIME 2:36pm

DURATION 3 hours 9 minutes

**ATTENDEES** 

WHAT HAPPENED? SAR received a page for a 40-year-old female with a reported compound fracture of the lower leg. Possible nurse on scene and patient reported to be four towers from the summit of Exhibition lift. Based on limited information due to a language barrier the team was paged to the hangar. One SAR member was at Snow King working and headed directly to the patient with phone but no radio, located patient and immediately assisted and treated lower ankle injury. SAR SUV drove up Snow King with wheeled litter, ALS, BLS equipment. Patient was located by team, reassessed, packaged and the team wheel littered the patient to the SUV. Patient was driven down Snow King and transferred to a waiting ambulance.

RESCUE **Injured Hiker on Snow King** 

DATE 6/25/17 TIME 2:15pm

DURATION 2 hours 45 minutes

**ATTENDEES** 

WHAT HAPPENED? SAR received a page for a 70-year-old female who was reported to have severe knee injury. The team was paged directly to the Snow King ball field. One SAR member was dispatched up the main chair to assess and locate the patient. Medic 10 was transported via 4-wheeler to patient. SAR drove the Tahoe to the top for patient transport. Two additional SAR members took the chair to the top with the wheeled litter strapped to the chair. Patient was assessed and packaged by Medic 10 and SAR. Patient transported via SUV to waiting ambulance.

RESCUE Goodwin Peak Rescue

DATE 6/25/17 TIME 4:03pm

4 hours 57 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a page of a female yelling for help and requesting SAR near the Goodwin Lake area. The team was paged to the hangar to determine options. A team was sent to a forward location to stage. Remainder of responders stayed at the hangar and put together options to either fly or respond via ground options. Dispatch contacted GTNP and GTNP sent

a team via Heli to do a recon. Helicopter recon found a person waiving and landed. GTNP Ranger was inserted to location to meet patient. Ranger walked patient down off snow to lower location and SAR team met the party and hiked them out.

RESCUE **Injured Mountain Biker on Putt-Putt Trail** 

DATE 6/28/17 TIME 7:46pm

1 hour 14 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a page for a report of a male mountain biker on Putt-Putt trail with a broken wrist. Dispatch advised that the cyclist was fading in an out of consciousness, had an injured wrist and had lost consciousness twice. During the call one SAR member could see the reporting party and injured cyclist thru a spotting scope from his home. SAR volunteer immediately drove to the Cache Creek parking lot to locate the party. SAR member reached the patient and dispatch contacted Medic 10 to meet them at the parking lot. SAR volunteer walked the patient to the parking lot. Medic 10 arrived and assessed the cyclist.

#### » JULY

RESCUE **Injured Hiker at JHMR** 

DATE 7/2/17 TIME 9:27pm

2 hours 48 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a page for an injured hiker somewhere on R Trail at JHMR. Dispatch reported that a female had a knee injury and was on the trail/road and could no longer hike down. Team dispatched to the Mountain Operations Building at JHMR. Injured party was believed to be located on the main road between the top of tram and top of gondola and was hobbling slowly downhill to try to make progress towards the top of the gondola. ATV team drove up the road to try and locate the party from the bottom up. Wheeled litter team rode up the gondola to try and locate the party. Both teams arrived at the patient at about the same time. The patient was located about 150 yards downhill from the top of the gondola. The patient was assessed and SAR members loaded the patient onto an ATV and drove her to the top of the gondola. SAR members rode down the gondola with her and transferred her to an ambulance.

RESCUE Missing Boater on Snake River DATE

7/4/17 - 7/10/17

7:51pm TIME

DURATION 38 hours 25 minutes

**ATTENDEES** 

WHAT HAPPENED? SAR was paged with a report of flipped raft in the Snake River near Astoria. Possibly 2 boaters in the river. The team was paged to the hangar for a river search. Teams performed Jet boat sweeps from Astoria North to King's Wave area. Confirmed that 6 boaters went in the river and 5 got out or were picked up. One remained missing. Last seen point just below King's Wave. Missing boater was not found. Team stood down at 21:37 due to darkness and returned to hangar. On second day 7 hasty teams were sent into the field. Teams included 2 jet boat teams, 2 cataraft dog teams, 2 rafts, jetskis and inflatable kayaks. At 11:30am a Lincoln County team found a dry bag just south of Astoria. At 1:16pm another team found a blue and vellow Leisure Sports paddle. Teams were off the river at 4:30pm. Day 3 SAR deployed Jet boat, Zodiac, two catarafts, two dog teams, forward repeater and shuttle drivers. Additional resources included BTNF river rangers and Lincoln County SAR. TCSAR continued searching with Tip Top SAR's sonar from the jet boat and completed the section between Astoria and King's Wave. On Sunday evening 7/9/17, Lincoln County requested TCSAR help continue the search in Lincoln County after a report came in that a witness had seen what looked like a body floating in Taco Hole. At 8:30am on 7/10/17, TCSAR took the cataraft and Jet boat down the Snake River between Taco Hole and Sheep's Gulch. They did not find any clues or the subject. That evening, Lincoln County sent dog teams to search the area around Taco Hole. The dogs signaled a lot but did not find the subject. The body of the missing boater was discovered by a kayaker near Alpine on 7/12/17.


RESCUE Lost Hikers near Summit at JHMR

DATE 7/5/17 TIME 2:31pm 40 minutes DURATION


**ATTENDEES** 

WHAT HAPPENED? SAR received a page for 2 subjects hiking and in distress. The subjects were on top of a rock hill and could see the back of Rendezvous Peak. Dispatch reported that the subjects hiked from Teton Pass and intended on hiking to the top of the tram. They were out of water, lost their bear spray and lost the trail. SAR decided to call the subjects to try and determine where they were and if they could talk them back


### ACTIVE SAR INCIDENTS PER WINTER




# ACTIVE SAR INCIDENTS PER SUMMER

to a place they knew. After talking with the subjects, SAR determined that the party was in GTNP. Dispatch passed the call onto GTNP and they handled the situation. SAR stood down.

RESCUE Injured Horseback Rider near Enos Lake

DATE 7/11/17 2:49am TIME

4 hours 11 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a page 2:49am for a report of a 60-year-old male who was injured as the result of a horseback incident. Patient was injured at 7:00pm and reporting party rode 5 hours out to obtain cell service. Injuries reported to be possible head, concussion, spine and he was in and out of consciousness but not bleeding. The injured party was somewhere near the intersection on the trail to Hawks Nest and Two Ocean Pass. No coordinates. SAR members worked on SARTOPO and Google Earth to try to get a better location. SAR held a second conference call at 3:20am and after more discussion it was decided to call Life Flight to fly with Night-Vision Goggles and search for the parties. Life Flight was confirmed to fly, and a SAR member went to hangar to monitor frequencies. Life Flight flew and located the injured party at 6:00am and landed, assessed patient and transported to EIRMC.

RESCUE **Buffalo Fork Kayaker Rescue** 

DATE 7/12/17 TIME 12:29pm

5 hours 47 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a report of woman kayaking on the Buffalo Fork who had swam and was stuck on the side of the river opposite the road. Team was paged to respond to the hangar to pick up the Catarafts. When SAR team arrived on scene they were able to locate a small side channel near the road and dispatched two team members on the Cataraft to float to the scene. Team was able to eddy out behind the strainer that the patient had been stuck in and locate her and her husband on shore. After ensuring that they were uninjured team loaded them and one kayak on the Cataraft and ferried across the river. Team members with the vehicles located a suitable take out approximately 2 miles down stream.

RESCUE Flipped Canoe at King's Wave

DATE 7/13/17 TIME 2:00pm **DURATION** 1 hour **ATTENDEES** 3

WHAT HAPPENED? While using the sonar equipment to search for a missing boater, TCSAR and Tip Top SAR rescued 2 boys who fell out of their canoe after it capsized in King's Wave. TCSAR threw them throw bags, the team pulled them into the jet boat and drove them to shore.

RESCUE **Broken Ankle on Mount Glory** DATE 7/26/17

TIME 12:14pm DURATION 5 hours **ATTENDEES** 

WHAT HAPPENED? SAR received a call regarding a possible broken ankle on Glory Mountain. The reporting party was a SAR team member. While hiking the SAR member saw the 41-year-old female hiker stumble and hurt her right ankle. They were located about 3/4 of the way up Glory just below the microwave panel. She stated that she could not hike down by herself so SAR member offered to call for assistance. SAR sent a team with the extremity vacuum splint to quickly hike up to the patient and provide patient care. After more SAR members arrived at the hangar, a hasty team was sent in with the wheeled litter, BLS bag and ALS bag. Once on scene, the patient was splinted and packaged into the wheeled litter. Using an anchored belay system, the SAR team belayed the wheeled litter down the trail. SAR transferred the patient to an ambulance to the top of Teton Pass.

RESCUE **Medical Evacuation near Coyote Meadows** DATE 7/28/17 TIME 4:00pm

DURATION 1 hour **ATTENDEES** 13

WHAT HAPPENED? SAR received a page for a sick male hiker in the Grizzly Creek area. The reporting party was a SAR team member who reported the patient was in a sleeping bag, had difficulty breathing and was shivering. Blood pressure was dropping but pulse ok. Team was paged to hangar and medical control was contacted. EIRMC HEMS was requested through dispatch and was sent to location. SAR member on site would manage the landing zone. SAR monitored TCSO dispatch for updates and team remained on standby. HEMS landed and transported patient to SJMC.

Fisherman Overboard on Snake River RESCUE DATE 7/30/17

TIME 1:38pm

3 hours 22 minutes DURATION

**ATTENDEES** 

WHAT HAPPENED? SAR received a call for a 62-year-old male who had gone into the Snake River 10 minutes prior south of Wilson from a boat and had not resurfaced. Team paged to the hangar for a swiftwater rescue. Jet boat and Zodiac boat teams sent to South Park Snake River put-in. Jet boat was equipped with ALS equipment. They immediately went upstream and met second reporting party and River guides who had pulled the patient from the river onto a small gravel island. Four guides had performed CPR on the patient with AED. Patient was immediately transferred to Jet Boat 1, continued CPR en route, and was transported downstream. After approximately 45 minutes of treatment, resuscitation and intervention from JHFEMS and TCSAR treatment was discontinued and the County Coroner was called to the scene. The patient could not be revived.

RESCUE Runaway Juvenile in Teton Canyon

DATE 7/30/17 TIME 10:03pm DURATION 7 minutes

**ATTENDEES** 

WHAT HAPPENED? SAR received a page regarding a missing runaway juvenile in the Teton Canyon area. The subject was last seen about 6 hours prior and would be on foot likely headed to Driggs. SAR called Dispatch to determine if this was a SAR call or a law enforcement call. Since there was no evidence the subject was in the backcountry, SAR was stood down.

#### » AUGUST

RESCUE Overdue Mountain Biker

DATE 8/4/17 TIME 7:07pm 7 minutes DURATION **ATTENDEES** 

WHAT HAPPENED? SAR received a page regarding a 14-year-old mountain biker last seen in city limits riding Josie's Ridge. The subject could have ended up in the county on the bike trails. Dispatch reported that a police officer called asking to talk with SAR about the incident. Before the conference call was done and prior to paging the team, the subject showed up and was ok. The incident was stood down.

RESCUE Broken Leg at Flat Creek

DATE 8/9/17 TIME 3:12pm

DURATION 4 hours 33 minutes

ATTENDEES 23

WHAT HAPPENED? SAR received a page regarding a patient complaining of a broken tib/fib on an unmarked trail just above Flat Creek Ranch. The team was paged and prepared the ATV's and gear for the field. Three teams left the hangar and reached the patient. Patient was splinted, packaged and transferred to a wheeled litter for transport to Flat Creek Ranch.

**RESCUE** Broken Ankle on Jimmy's Mom Trail

DATE 8/12/17 TIME 12:20pm

DURATION 1 hour 55 minutes

ATTENDEES

WHAT HAPPENED? While SAR team training in the Ice/Wind Caves was occurring, SAR was paged with a report of a broken ankle on Jimmy's Mom trail on Teton Pass. Available SAR team members responded to the hangar and were sent into the field with ATVs. Patient was contacted and an assessment was done. A vacuum splint was applied to the extremity and the patient was transferred to Incident Command Post. Patient transferred to ambulance.

**RESCUE** Bear Encounter in Buffalo Valley

DATE 8/17/17 TIME 7:19pm

DURATION 1 hour 45 minutes

ATTENDEES 19

WHAT HAPPENED? SAR received a page regarding a near bear attack near Turpin Meadows. The man had discharged bear spray and escaped up a tree. He was too scared to come down because the bear was still in the area. Dispatch reported that the cell ping was not accurate and plotted in Jensen Canyon. SAR called the reporting party to get more info and called the USFS to see if anyone could help respond. It was discovered that the mother-in-law was the reporting party and the subject had hiked up a trail directly behind the house on Buffalo Valley Road. He was about 2 miles up the trail and she sent a group of neighbors up the trail to help find him. The team was paged to the hangar and gathered necessary equipment and sent 2 teams to the location. Dispatch then reported that the subject had been found by the group of neighbors and was ok. They would hike out together. SAR was stood down.

RESCUE Stranded Hikers on Table Mountain

DATE 8/17/17 TIME 9:27pm

DURATION 1 hour 23 minutes

ATTENDEES

WHAT HAPPENED? SAR received a page for possible stranded hikers on Table Mountain. Dispatch reported that reporting party (RP) had passed two hikers, one male and one female, who might be stranded. The male was reported to be using crutches and had a prosthetic leg. SAR called the RP for more info. He suspected the party would not be able to make it down the trail. They were approximately 4 miles up the Long Trail when he passed them. They only had a daypack and no light but no injuries. Since there was no report of missing or overdue hikers or injured hikers it was determined to send a person to monitor the trailhead. A SAR member went to the trailhead at approximately 8:00pm and waited to see if the hikers arrived and would report back. At 8:50pm the SAR member located the party and they were ok.

RESCUE Overdue Hiker near JHMR

DATE 8/19/17 TIME 6:20pm

DURATION 2 hours 7 minutes

ATTENDEES 15

WHAT HAPPENED? SAR received a page regarding an overdue hiker southwest of JHMR. Dispatch reported the subject became separated from his hiking party and was now 2 hours overdue. The reporting party (RP) was hiking with the subject but did not have his phone number. SAR asked dispatch to notify GTNP and JHMR since the subject may end up in their jurisdictions and SAR called the RP to get more info. In the meantime the subject was reported to be at the top of the tram. SAR was stood down.

RESCUE ATV Accident near Rapid Creek

DATE 8/20/17 TIME 1:13pm

DURATION 3 hours 47 minutes

ATTENDEES 1

WHAT HAPPENED? SAR received a call from Dispatch indicating an ATV accident occurred and CPR was in progress. TCSAR responded with two teams with ATVs. TCSAR contacted GTNP to inquire if a helicopter was available. Teton County Idaho Search and Rescue was authorized by the Teton County Idaho Sheriff to support the incident. TCISAR mobilized ATVs and a wheeled litter. A paramedic from Teton County Idaho FEMS was on scene






# INCIDENTS BY DAY OF WEEK WINTER 2016/2017

RAY SHRIVER served on the Teton County Search and Rescue team from its inception in 1993 until his death in 2012. His dedication to training and education was unmatched in the search and rescue community — during his 19 years, Ray volunteered more hours to rescue and training than anyone else in Teton County history. Shriver specialized in training canines, and his search dogs were renowned. His sincere and passionate commitment to Jackson Hole and the area continues to be respected and honored today. Ray was killed in February 2012 in a helicopter crash while on a search and rescue mission.

The Shriver Society was created in memory of Ray to ensure that the unpaid team of specialized, volunteer rescuers will be financially supported for the life of the TCSAR organization.
